- This list is based on the Royal College of Emergency Medicine (RCEM) and National Poisons
 Information Service (NPIS) guideline on <u>antidote availability for emergency departments</u> and <u>stocking guidance</u> (August 2021)
- <u>TOXBASE</u>, Departmental guidelines and/or the <u>BNF/BNFc</u> must be consulted for advice on doses and indications for antidote administration.
- If necessary the National Poisons Information Service (NPIS) should be telephoned for more patient-specific advice on 0844 892 0111.
- Additional drugs that are used in the poisoned patient that are widely available in ED are not listed in the table.

Botulinum antitoxin	Botulism
Glucarpidase	Methotrexate
Pralidoxime chloride	Organophosphorus insecticides
Sodium calcium edetate	Heavy metals (particularly lead)
Succimer (DMSA)	Heavy metals (particularly lead and arsenic)
Unithiol (DMPS)	Heavy metals (particularly mercury)
Uridine Triacetate	5-Fluorouracil or Capecitabine

Antivenoms for non-indigenous venomous animals – seek advice from NPIS. If indicated, antivenom can be ordered with Movianto by either NPIS or a national antivenom expert for both in and out of hours delivery.

The RCEM & Toxbase advise that it is not considered essential to hold the following drugs (for the purpose as antidotes): Benzatropine, Dicobalt Edetate, Dimercaprol, Methionine, Penicillamine, Phentolamine, Physostigmine, Sodium Nitrite.
