

BD Vacutainer® Safety-Lok™ Blood Collection Set




- **1a** With gloved hands, peel back the packaging at the arrow so that the wingset is exposed.
- **1b** With your thumb and index finger, grasp the body of the wingset and remove it from the packaging.
- **1c** Attach a BD Vacutainer® Single Use Holder.



2 Hold the textured side of the wings together with your thumb and index finger. Remove the needle cover and perform the venepuncture according to your organisation's policies and procedures.



3 Grasp the grip at the end of the safety shield between your thumb and index finger. Withdraw the needle from the vein. Apply pressure to the site according to your organisation's policies and procedures.



4 Use your remaining fingers to hold the tubing securely against the palm of your hand. Now, push your thumb and index finger forward, sliding the safety shield until it covers the tip of the needle. Activation is confirmed by an audible click.



5 After activating the safety shield, discard immediately into an approved sharps container. Dispose of the needle and the single use holder together. If not using a single use holder, follow the manufacturer's instructions for disassembly.
